

ESF Programme Update

- Projects to be funded up until UK leaves the EU even if projects' funding runs beyond the UK leaving the EU
- Projects submitted after the 2016 Autumn Statement will need to meet domestic priorities & provide VfM
- ESIF Committees to advise on VfM on all new applications
- Contract management & project evaluation being strengthened
- DWP currently reviewing future call arrangements.
- C2C hoping for new round of ESF calls from June 2017
- ESIF Committee next meeting 24 March to review draft call specifications

1.1 Access to employment for job-seekers and inactive people

Access to employment for job seekers and inactive people, including the long term unemployed and people far from the labour market, also through local employment initiatives and support for labour mobility;

- To improve the employability of long-term unemployed people, so that they can compete effectively in the labour market.
- To provide individuals from groups which face particular labour market disadvantage with additional support so that they can compete effectively in the labour market
- To encourage inactive people to participate in the labour market and to improve their employability
- To address the basic skills needs of unemployed and inactive people so that they can compete effectively in the labour market.
- To provide support for women at a disadvantage in the labour market, and particularly those who are currently inactive, to contribute to our efforts to reduce the gender employment gap.

• Support for target groups from pre work through to sustained employment (£1.34m)

Potential future opportunities – ideas so far (£3.36m)

Project linked to Troubled Families Programme to support those in need of skills to gain access to employment and progression through training and supported employment initiatives to fill skills shortage occupations e.g. construction, care, hospitality etc. Anticipate the loss of workers due to Brexit. Provide brokering with the employers, support adult traineeships, job carving and other approaches to supporting employment





1.4 Active inclusion

Active inclusion, including with a view to promoting equal opportunities and active participation, and improving employability

- To support people with multiple and complex barriers to participation to address these underlying issues and to move closer to or into the labour market.
- To support prisoners in custody and on release, and those without work who are serving sentences in the community, to improve their employability.
- To engage marginalised individuals and support them to re-engage
