

<b>CORE OUTPUTS: Jobs, Homes and Employment Space</b>	<b><u>BIS Definition</u></b>
Jobs directly connected to the intervention	<p>Permanent paid full time equivalent jobs that are newly created as a direct result of the intervention, at the "impact sites". This includes: - Employment on occupied commercial premises (in the case of site development) - Employment in supported enterprises (in the case of business or innovation support) - Employment in FE space directly improved or constructed by the intervention.</p> <p>"Impact" sites are those sites where there has been a demonstrable unlocking impact as a result of Growth Deals projects (e.g. transport, skills capital)</p> <p>Jobs created solely to deliver the intervention, e.g. Construction jobs should not be included. Projects may collect this data either by survey of the impact site or by reports from pre-selected firms.</p>
Safeguarded Jobs	Permanent paid full time equivalent jobs that are safeguarded as a direct result of the intervention, at the "impact sites". A job safeguarded is one that has been at risk for at least one year and should be sustained for at least 24 months.
Indirect Jobs	Permanent paid full time equivalent jobs that are newly created as an indirect result of the intervention, not at the impact site.
Amount of indirect Private Sector Leverage	The volume of private sector investment over and above that directly associated with the project costs where there is a demonstrable link with the project. This should not include in-kind contributions.
Amount of indirect Public Sector Leverage	The volume of public sector investment over and above that directly associated with the project costs where there is a demonstrable link with the project. This should not include in-kind contributions.
In-kind resources	Land, buildings or other assets provided to resource the intervention. Indicate what type of asset, size, source and where possible a market value. Example might include 5 ha of brownfield land from local authority X valued at £300,000 or 200 sqm of office space from the HCA valued at £1 million.
Commercial Floorspace refurbished	For project sites, the area and class of commercial floorspace refurbished in sq. Floor areas should be measured in accordance with the RICS Code of measuring practice (6th edition) 2007
Commercial floorspace constructed	For project sites, the area and class of commercial floorspace newly constructed in sqm. Floor areas should be measured in accordance with the RICS Code of measuring practice (6th edition) 2007
Housing units starts	For both direct housing sites and "impact" sites, the number of housing units for which construction has started. "Impact" sites are those sites where there has been a demonstrable unlocking impact as a result of Growth Deals projects (e.g. transport, skills capital)

Housing units completed	For both direct housing sites and "impact" sites, the number of housing units for which have been completed. "Impact" sites are those sites where there has been a demonstrable unlocking impact as a result of Growth Deals projects (e.g. transport, skills capital)
<b><u>Transport Outputs</u></b>	
Total length of resurfaced roads	Length of road for which maintenance works have been completed
Total length of newly built roads	Length of road for which works have been completed and now open for public use
Total length of new cycle ways	Length of cycle ways for which works have been completed and now open for public use
Type of infrastructure (Please provide a description and a number in the years in which it will be delivered)	Identify what has been constructed as a result of the project - utilise units where appropriate
Type of service improvement (please provide a description in the year in which it will be delivered)	Identify the nature of service improvement as a result of the intervention e.g. improved bus service
<b><u>Land, Property and Flood Protection</u></b>	
Area of site reclaimed, (re)developed or assembled	Area of land directly improved by the project that is now suitable for commercial development where previously it was unattractive to commercial developers. Reclaimed: making the land fit for use by removing physical constraints to development or improving the land for hard end use; providing services to open it up for development, e.g. provision of utilities or service roads
Utilities installed	Length of cabling/piping installed in kilometres
Area of land experiencing a reduction in flooding likelihood	Area of land with a reduced likelihood of flooding as a result of the project
Increased number of homes protected from flooding	Number of homes with a reduced likelihood of flooding as a result of the project
Increased number of jobs protected from flooding	Number of jobs protected from flooding as a result of the project
Number of jobs created as a result of flood protection	Number of jobs indirectly created as a result of increased flood protection
Employment space protected from flooding	The area and class of commercial floorspace protected as a result of the project in sqm.
<b><u>Business Support</u></b>	
Number of enterprises receiving non-financial support	Number of SMEs receiving support (including advice and training) with the intention of improving performance (i.e. reduce costs, increase turnover/profit, innovation, exporting). Value of the support should be a minimum of £1,000, calculated at Gross Grant Equivalent (see ERDF guidance) or a minimum of 2 days of consulting advice.
Number of new enterprises supported	As above, but businesses that have been trading for less than three years.
Number of potential entrepreneurs assisted to be enterprise ready	Number of individuals receiving non-financial support (i.e. advice or training) with the intention of commencement of trading
Number of enterprises receiving grant support	Number of SMEs receiving grant funding support with the intention of improving performance (i.e. reduce costs,

	increase turnover/profit, innovation, exporting). To be counted where the support is at least £1,000.
Number of enterprises receiving financial support other than grants	Number of SMEs receiving funding support in the form of equity or repayable loan instruments with the intention of improving performance (i.e. reduce costs, increase turnover/profit, innovation, exporting). Counted where amount of support is at least £1,000.
Number of enterprises assisted to cooperate with research entities/institutions	The number of treated SMEs working jointly with research entities after assistance has been given. Should be counted up to 3 years following support. Knowledge transfer is about transferring good ideas, research results and skills between the knowledge base and business to enable innovative new products and services to be developed
Number of enterprises supported to introduce new to the market products	The number of treated SMEs that successfully introduce a new-to-market product after assistance has been given. Product should be available for commercial purchase. Should be counted up to 3 years following support.
Number of enterprises supported to introduce new to the firm products	The number of treated SMEs that successfully introduce a new-to-firm product after assistance has been given. Product should be available for commercial purchase Should be counted up to 3 years following support.
Additional businesses with broadband access of at least 30mbps	For broadband interventions only: number of additional commercial premises that, as a result of intervention, now have the option to access broadband of at least 30mbps (average), where this was not previously the case
Financial return on access to finance schemes	The financial return to the scheme associated with revolving/repayable access to finance interventions - measured as a % return on initial investment.
<b>Skills</b>	
New build training/learning floorspace	The amount of "new build" training/learning floorspace constructed.
Refurbished training/learning facilities	The amount of refurbished training/learning floorspace constructed.
Floorspace rationalised	The amount of overall floorspace reduced following completion of the project through, for example, demolition or disposal.
Number of additional learners	A full time student enrolled in a college and attending for at least 15 hours per week.
Number of additional apprentices	Apprenticeships are paid jobs that incorporate on- and off-the-job training leading to nationally recognised qualifications. As an employee, Apprentices earn as they learn and gain practical skills in the workplace. An Apprenticeship framework typically contains the following separately certified elements: - A knowledge-based element (the theoretical knowledge underpinning a job in a certain occupation and industry, typically certified via a Technical Certificate). - A competence-based element (the ability to discharge the functions of a certain occupation, typically certified via work based assessed national vocational qualifications - NVQs). -Transferable skills (English and maths) - key skills / functional skills. - A module on employment rights and responsibilities. - Personal Learning and Thinking Skills (PLTS): independent enquiry, creative thinking, reflective learning, team working, self-management, effective participation.
