## The opportunity

You will have experience of working with national policy and translating it into strategy, of working with Government and of building credibility and influence with a wide range of local stakeholders. You will be creative and flexible, and able to work effectively in a small team. You will be able to manage competing priorities, and will relish the opportunities of being part of a fast-paced environment at the heart of economic growth.

- 1. Co-ordinate and deliver a Coast to Capital regional response to Government policy and deliver a work programme that supports the development and implementation of related initiatives.
- 2. Support the Head of Strategy and Policy to develop, review and deliver on Coast to Capital's overarching strategies for economic growth such as the Strategic Economic Plan, local Industrial Strategy, Energy Strategy and Newhaven Enterprise Zone Strategy.
- 3. Develop the research and analysis function of the team to ensure that our strategic leadership and investment strategy is grounded in strong evidence.
- 4. Build new and maintain existing relationships with key partners and stakeholders in order to support the delivery of Coast to Capital's priorities as identified in our Strategic Economic Plan and other related strategies.
- 5. Deputise, as directed, for the Head of Strategy and Policy, to ensure the Strategy and Policy team is well resourced and managed in order to deliver on its programme of work.
- 6. Produce high quality reports and papers for the Coast to Capital Board, Committees and senior level partners and stakeholders.



7. Act as an ambassador for Coast to Capital, supporting us to be an innovative, engaging and highly regarded LEP whose added value is well understood by partners both locally and within Government.
